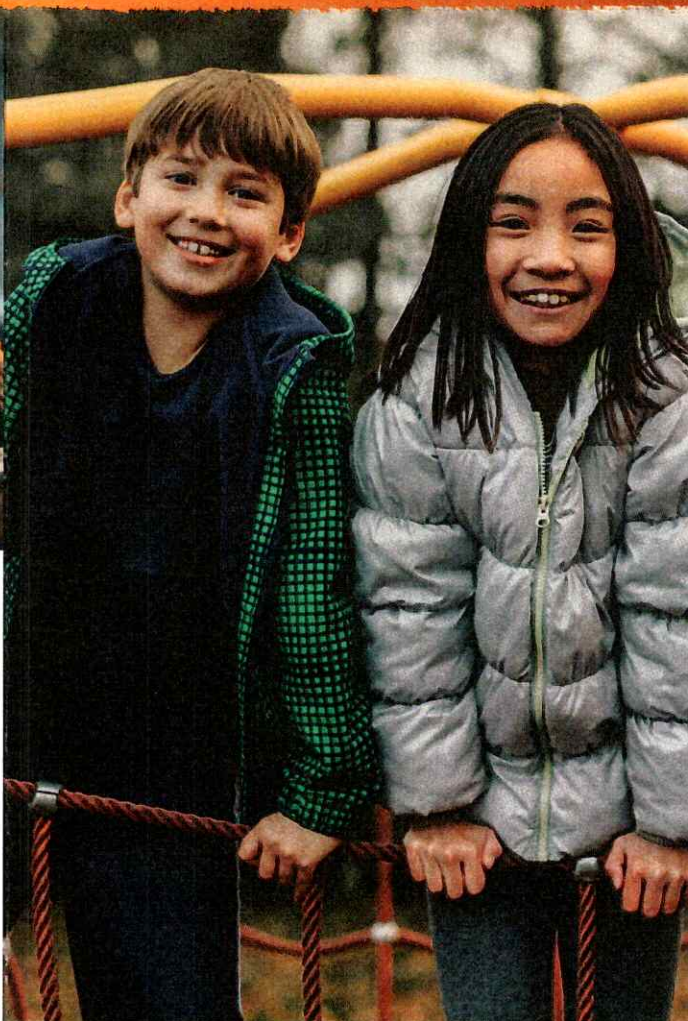

Who can get involved in the YMCA Financial Assistance Program?

Families or individuals who are unable to pay the full fee for a standard membership or program. Also, those who currently receive fee assistance from the government prequalify for the program.

How does the YMCA decide how much I pay?

Every family or individual pays what they can afford based on their total household income. This amount is determined in the application process.

How is the YMCA able to provide the Financial Assistance Program?

YMCA donors and partners believe that no one should miss out on a YMCA opportunity and so they give generously to ensure the Y is open to all. Each year the YMCA provides assistance to over 12,000 people.

What happens to the personal information in my application?

All personal information is kept private and confidential. Our privacy policy can be found at gvymca.ca

How do YMCA renewals work?

All memberships are automatically renewed, child care for three months, registered programs for the duration of the program, and camps for the camping season. Applicants may re-apply to renew their space in the YMCA Financial Assistance Program.

What documents will I need to submit to qualify for the YMCA Financial Assistance Program?

Please attach one of the following documents with your application for each person living in the household:

- Prior year's Notice of Assessment from Revenue Canada
- Prior year's Income Tax Return
- In the case of those who do not file Tax Returns, please attach the last three pay stubs for those in the household earning income

Once your application is reviewed, you are responsible for providing:

- First payment for program or membership
- A method of automatic payment (i.e. a void cheque, credit card information, or a pre-authorized form from your bank)
